## PRODUCT INFORMATION

**ECOMAXIMA WSP** is a dry 100% water soluble plant nutrient derived from non GMO Soy protein and Potassium Orthophosphate with microencapsulation technology. **ECOMAXIMA** is designed for all crops, turf and home gardens.

The product is recommended for soil, foliar and drip based applications.

## DIRECTIONS FOR USE

Recommended for all crops including vegetables, fruit trees, nut trees, row crops, feed and forage crops, ornamental trees, flowers, shrubs, container plants, turf and public greens.

### FOLIAR USE:

Apply 2-8 Pounds per acre. Applications may be made 7-14 days intervals.

### SOIL USE:

Apply 4-16 Pounds per acre as spot drenching to plants.

### DRIP USE:

Apply 2-8 Pounds per acre. Applications may be made 7-14 days intervals.

### SPRINKLER USE:

Apply 8-16 Pounds per acre. Applications may be made 7-14 days intervals.

### CONTAINER AND NURSERY PLANTS:

Apply 2-4 Tbs. per Gallon water as a soil drench application.

### LAWN AND HOME GARDENS:

Apply 1-2 Tbs. per Gallon water and make foliar (or) soil application.

### TANK COMPATIBILITY SUGGESTIONS:

Perform compatibility test prior to tank mixing with other products. It is recommended to check plant safety tests prior to application to young and sensitive vegetation.
