PRODUCT INFORMATION

ECOSTIM PLUS 0-0-10 is a 100% water soluble seaweed extract nutrient derived from red seaweed, *Kappaphycus alvarezii* and Calcium chloride. When applied as per recommendations, it will help correct potassium and calcium deficiency of crops.

ECOSTIM PLUS 0-0-10 will improve crop nutrition, boost growth and crop vigor to enhance yield potential of crops. It is recommended for conventional fertilization programs.

ECOSTIM PLUS 0-0-10 can be used for foliar, aerial and chemigation based applications in crops at all stages. Application during early planting stages, pre-bloom and post-bloom season is recommended specifically.

DIRECTIONS FOR USE

Shake very well before use.

ECOSTIM PLUS 0-0-10 can be applied to all agricultural and horticultural crops including vegetables, fruit trees, nut trees, row crops, feed and forage.

Crop Foliar Rates: Apply 1 - 4 Pints/Acre. Multiple applications may be made at 7-14 day intervals.

Crop Drip Rates: Apply 1 - 4 Pints/Acre. Multiple applications may be made at 7-14 day intervals.

Crop Sprinkler Rates: Apply 1 - 4 Pints/ Acre.

COMPATIBILITY

ECOSTIM PLUS 0-0-10 is generally compatible with all with wide range of nutrients and agrochemicals, however, a compatibility test is recommended prior to large area applications.

APPLICATION VOLUME

Apply ECOSTIM PLUS 0-0-10 in 25-50 gallons of water when using up to 2 pints/acre. If rates of 3-4 pints/acre are used, spray volume optionally may be increased up to 80-100 gallons/acre.

Storage: Store in the original container in a cool, dry place away from excessive moisture and heat. Recap container after each use.

Caution: May be harmful if swallowed. Avoid contact with eyes. Do not inhale spray mist. Wash hands after use. For general cleaning, use warm soap water.
